SL will produce a new form. SL will also produce an expenses policy document to be considered at the next Management Board meeting,	SL

SL replied that, for this year, there had been an increase in entry fees for the county swimming championships, and that increasing capitation fees could be considered, if necessary, in the future.

		JH reported that a Special Olympics gala is scheduled for March at Hertfordshire Sports Village. JH reported further on the lack of classifiers. Two classification opportunities had been cancelled in the last 12 months. The classification scheduled for the Development Weekend in February will not now be possible. A classification team is being trained at present. JH is to be contacted regarding a blind swimmer at Verulam ASC.

20/	10.5	Swimming committee: Minutes for the meeting on 7.11.19 were received and noted.	
		BT advised of his proposal to restructure the swimming committee and assign roles to the members in order to spread the workload. BT further advised that a job specification has been sent out for team managers for the inter-county teams. Although there are high numbers of team managers in the county, no-one is stepping forward to fill the roles required for the county team competitions. The withdrawal of	

the county teams could be the outcome if no volunteers are found.

20/10.6 Synchronised swimming committee: Minutes of the meeting on 14.1.20 were received and noted.

It was disappointing that only two clubs were represented at the meeting, but it was noted that all clubs are still involved in the development and the competitions being run in the region.

20/11 Diving committee

- 20/11.1 SM had written to the diving manager, Alex Belson, following the last Management Board meeting, advising her of the decision of the Management Board with regard to the diving committee and the county diving events. The responses of Alex Belson and Roger Page, a member of the diving committee, were provided to the Board.
- 20/11.2 Alex Belson had been invited to attend this meeting, but had replied that she was not able to attend.
- 20/11.3 The Management Board upheld the decision made at the October meeting, that:-

The Swim England Hertfordshire diving committee will be suspended. The county championships results will be established via the regional championships, as is the case for the disciplines of synchronised swimming and open water.

A stand-alone county diving event will not take place.

20/13 County colours

- 20/13.1 Agreed county half-colours for swimming were presented in January at the County Swimming Championships and Age-Groups 2020. These were for athletes who represented the county at the National Inter-County Team Championships in October 2019.
- 20/13.2 Agreed county colours for disability were presented to Mark Evens (Hitchin SC) in January at the County Swimming Championships and Age-Groups 2020. This was in recognition of a world record swim, as part of the GB team, at the 5th European Down Syndrome Swimming Championships.
- 20/13.3 Agreed county colours for diving are ready to be presented to the athletes at a suitable opportunity.

20/14 Hertfordshire Aquatics Group

- 20/14.1 BT reported that there was a change of contact for one of the parties involved in the project.
- 20/14.2 There is still positivity about the project, and the volunteer advisors are still working towards achieving the best possible, deliverable and sustainable facility, within the financial parameters. However, there is a degree of frustration about the slowness of progress.
- 20/14.3 A meeting with various parties is scheduled for June, and it is hoped that positive progress in resolving issues will be made before then, so that decisions can be made to take the project forward.
- 20/14.4 One of the directors of the Hertfordshire Aquatics company is no longer a member of the Management Board, and it was decided that BT would contact Graham Huggett with a view to him standing down as a director. It was decided that a replacement would not be appointed, the number of directors to now be three Bryan Thompson, Ian Mackenzie and Simon Lever.

20/15.1 At the Swim England Annual General Meeting on 12th October 2019, Ian Mackenzie was inaugurated as the Swim England President. He will hold that office until May 2021.
