#### 21/25 Discipline specific areas – Skills days

The first virtual skills day had taken place and most clubs felt there were some difficulties with it. It was felt it was a lot of work for people to try and film and upload multiple videos. The quality of the videos submitted varied massively from a judging perspective and it is very hard to find time during normal training sessions to do this and make sure there are no other swimmers or Coaches in the background.

It was questioned if there was a consistent approach across all judging and (TB) advised that his experience was that the head judge reviewed all marking and provided feedback if she felt something was not consistent with the overall judging.

The Region planned to run another virtual skills day later in the year and to take the learning from the first experience and try to improve where possible.
