		Artistic swimming committee: 12.10.21 No formal meeting took place. IM gave an update on the artistic swimming clubs in the county.				
		21/68.1.1 IM reported on the move of the artistic swimming coach at Cheshunt SC to Potters Bar Artistic Swimming Club. Artistic Swimming at Cheshunt SC had been struggling with small numbers and water time. With the move of the coach, Potters Bar Artistic Swimming Club had been strengthened, and artistic swimmers will now be better catered for at the four, rather than five, facilities where artistic swimming is delivered.

	21/68.4	Diving committee: Committee suspended IM gave an update on diving in the county.				
		21/68.4.1 IM reported that the majority of the county's diving trophies had been returned. The remaining

trophies are to be located by Roger Page, and returned by the winners at Dacorum Diving Club.

21/68.4.2 IM reported that both the county's diving clubs were struggling. Beaumont Diving Academy because Derek Beaumont, their coach, had had an accident, and was not available to coach. Whilst at Dacorum Diving Club, Chris White, their only coach, was struggling on his own to deliver the training.

21/68.4.3 A Dacorum Diving Club representative was intending to talk to Swim England and to the Council to see if the Council could take on the delivery of diving at Dacorum.

21/68.4.4 BT suggested that Hertfordshire Aquatics Club could perhaps facilitate the delivery of diving at both sites, by identifying a qualified coach to oversee both sites.

21/68.4.5 IM said that co-operation between the clubs is an issue, but there was certainly a need in the interim for a coach to be found quickly to assist Chris White.

21/68.5 Swimming committee 17.6.21: Minutes received and noted. Numbering will be corrected

21/68.6 Water polo: No committee

21/68.6.1 IM reported that the national review for water polo is progressing.

One outcome is that U.11 and U 13 players will benefit from regional festivals, with the hope of building the base of players in these lower age-groups, to develop them for the future.

21/69 County colours

- 21/69.1 There were no recommendations for county colours from the committees
- 21/69.2 Wilkinson Sword: Following the Tokyo Olympics and Paralympics, there were suggestions of possible awardees. This will be discussed and a decision made at the January Management Board meeting.

21/70 Hertfordshire Aquatics Group

- 21/70.1 The positive, regular, weekly meetings continue for the steering group.
- 21/70.2 New designs have been produced. It is for a 10-lane facility.
- 21/70.3 The possible uptake of use by swim schools is still being established.
- 21/70.4 There has been an approach from Welwyn Hatfield Council who are reviewing their provision of leisure facilities, and wanted to have information on the facility being planned and the proposed targeted users.
- 21/70.5 There is a scheduled meeting with Oaklands College on 15th November, when there will be an opportunity for the new personnel at the College fully appreciate the previous discussions and plans, as well as moving the project forward.

21/71 Swim England East Region

- 21/71.1 SM attended the Regional Operations Committee (ROC) on 20th September 2021.
 - 21/71.1.1 In July and August there were two swimming events a Future Champions Meet for younger age-groups, and a Festival of Swimming, replacing the Summer Nationals. Both events were well supported and successful, with athletes from Hertfordshire taking part.
 - 21/71.1.2 The terms of reference for the regional Leadership Groups have been written and are on the website.
 - 21/71.1.3 Following interviews, another member of staff has been appointed by Swim England East Region in a new administrative role.

21/71.1.4 There is a vacancy for a member of the Audit, Risk and Probity Committee, following a recent resignation.

21/71.2 SM attended the Swim England East Region County Forum on 22nd September 2021

21/71.2.1 There is now an automated poolside pass system available for coaches and team managers. The system provides a robust check on DBS status, attendance at safeguarding workshops and certifications, whilst providing a printable poolside pass. There are also online payment options if required.

21/71.2.2 The region has created a document which summarises the internal dispute procedure for clubs. It simplifies the processes outlined in the Swim England Handbook and includes a flowchart. It is on the region's website, and will be included in a future club newsletter.

21/71.2.3 The Committee congratulated a Swim England Hertfordshire athlete.

Maxwell Sewell from Aqualina (Stevenage) Artistic Swimming Club, recently won bronze in the duet at the European Artistic Swimming Championships- the first ever medal in this category for Great Britain.

21/72 Any other business

- 21/72.1 IM advised that JH had been present, as Swim England East Region Disability manager, at an interregional disability meeting, where it was decided that there will be a disability competition run jointly by London Region and East Region.
- 21/72.2 SL raised the constitutional requirement for Hertfordshire Aquatics Club to hold regular committee meetings. As the committee members were also the members of the Management Advisory Group, it was decided that the Hertfordshire Aquatics Club meeting would be covered within the Management Advisory Group meeting for the present.
