The county and its athletes are indebted to Dave for his work over many, many years, especially for the discipline of water polo. A sympathy card was sent to Dave's family expressing condolences and acknowledging Dave's huge contribution to our sport.	
23/62.2	SM has received the usual electronic communication of Swim England member news and the Swim England East Region's newsletter, which are also sent to the county's Swim England members and the county's clubs respectively.	
23/62.3	Swim England East Region has received an application from Beaumont Diving Academy to change its name to Hatfield Diving Club. The county has to advise of any concerns about this. There was no objection to this name change, and SM will advise the region accordingly.	SM

	23/62.4.3 From November there will be an Equity, Diversity and Inclusion Action Plan (DIAP) requirement for SwimMark and Club Affiliation, and relevant club personnel will have to attend two free relevant CPD courses.	
	23/62.4.4 There is now a requirement for the Chairman and the Welfare Officer to attend workshops and complete courses.	
	23/62.4.5 From January, only those with the required safeguard training and DBS status will be allowed on poolside.	
23/62.5	SM advised that there is to be a results uploader to enable promoters etc to upload results without going through the usual Swim England route. A key code will be provided to the promoter, and the results will appear on rankings within 2-3hrs. This results uploader is currently in the final testing stage.

		Historically the CDG also supported clubs, but Swim England now provides multiple avenues for clubs to access support with running the club and in club governance, including SwimMark and Club Affiliation, so this CDG role has become redundant.

There was discussion regarding the withdrawal of the county's team from The National Inter-County Team Championships. The reasons behind the withdrawal were clarified by BT. There was no issue with the process as such, and athletes were available, but BT was let down by individuals who had accepted a role and then withdrew, and by the lack of support when clubs/coaches/volunteers were asked to step up to fill the gaps. The athletes had been badly let down and every effort must be made to ensure that this does not happen again.

- 23/68.1 BT reported the continuation of meetings, but progress with the project is rather slow.
- 23/68.2 There is now a third Financial Director at Oaklands College, and there also needs to be a conversation with the Principal regarding his proposals for engagement with the project, as these are not viable from the county's point of view.
- 23/68.3 The business case needs to be revisited, highlighting the selling points, and the design and costs need to be reviewed.
- 23/68.4 The architects are producing a glossy brochure to advertise the project to possible funding bodies.
- 23/68.5 Other potential sites need to be kept in mind, but currently the business case is still built on the Oaklands

- 23/69.1. IM provided an update that the region has employed a welfare officer who can be used by the counties and the clubs, rather than having their own officer. The Regional Welfare Officer starts work at the end of October, and can be contacted by clubs or the county to deal with issues. This does not preclude clubs from retaining their own welfare officers who can liaise, if they wish, with the regional officer.
