24/1 Welcome

- 24/1.1 The Chairman, Bryan Thompson, welcomed everyone to the meeting, and introduced the Officers.

- 24/3 Minutes of the Annual Council Meeting held on 20th March, 2023

24/4 Matters arising from the minutes

24/4.1 Minute 23/6.1 The Finance Officer advised that the accounts accepted at last year's Annual Council Meeting had now been examined by the independent financial examiner.

24/7 Regulations

24/7.1 Three proposals for amendments to the Regulations were received from the Management Board.

24/7.2 **Proposal 1**

In line with recommendations from Swim England, replacing a reference to the Swim England Child Safeguarding Policy and Procedures with a reference to Wavepower

- 5.1.2 The Association shall be bound by Swim England Child Safeguarding Policy and Procedures, and those parts of Swim England Judicial Regulations and procedures necessary for their implementation.
- 5.1.3 All persons, clubs, associations, bodies, leagues and organisations allocated to the Association shall agree to be bound by Swim England Child Safeguarding Policy and Procedures, and those parts of the Swim England Judicial Regulations and procedures necessary for their implementation, and shall, when engaged in activities under the jurisdiction of the Association, be subject to the constraints and privileges of the Swim England Judicial Regulations.

Replaced with:-

- 5.1.2 The Association shall be bound by Swim England Wavepower, and those parts of Swim England Judicial Regulations and procedures necessary for their implementation.
- 5.1.3 All persons, clubs, associations, bodies, leagues and organisations allocated to the Association shall agree to be bound by Swim England Wavepower, and those parts of the Swim England Judicial Regulations and procedures necessary for their implementation, and shall, when engaged in activities under the jurisdiction of the Association, be subject to the constraints and privileges of the Swim England Judicial Regulations.

24/7.3 **Proposal 2**

In line with recommendations from Swim England, set a minimum age for members of Council.

11.1 Only persons who are members of Swim England and members of clubs allocated to Hertfordshire shall be eligible to be members of the Council.

Amend to:-

11.1 Only persons who are Swim England members aged 18 years or over, and members of clubs allocated to Hertfordshire shall be eligible to be members of Council.

24/7.4 **Proposal 3**

In line with recommendations from Swim England, the Welfare Officer will be appointed by the Management Board, not elected at Council.

Delete 11.6.5.7 and renumber the Regulations accordingly

Add

16.1.9 appoint annually the County Welfare Officer Renumber accordingly

a) Roy Rogers Memorial Trophy – The Roy Rogers Memorial Trophy is awarded annually to the Hertfordshire person, team or club who has made a significant contribution to the sport of swimming.

 Wilkinson Sword – The Wilkinson Sword is awarded annually for the highest achievement in the sport of swimming.
