24/68 Minutes of committees

- 24/68.1 Artistic Swimming committee: 11.7.24 Minutes received and noted.
- 24/68.2 Disability: Committee suspended
- 24/68.3 Diving: Committee suspended
- 24/68.4 Swimming committee 11.9.24: Minutes not yet available
 - 24/68.4.1 There was a proposal from the Swimming Committee that the county provides County Best Time certificates. These would be provided, on request only, to an athlete who had swum the best time for an event in the County Swimming Championships from the year 2016 onwards.
 - 24/68.4.2 BT explained that this is different from County Records which are achievable in any competition, not restricted to the annual County Swimming Championships.

It is unlikely that a younger swimmer would achieve a County Record, as that is open to all ages. Whereas County Best Times are age-group related,

24/68.4.3 It was agreed that County Best Time certificates would be provided if requested by a qualifying athlete.

24/68.4.3 BT reported on the National Inter-County event on 9th November. The Hertfordshire team comprised 28 athletes. The invitations were later than planned in being sent out. Unfortunately, the team was not actually the optimum possible from the athletes in the county, It was a long day as it had been decided that there would be no overnight stay this year. The team gave a good account of themselves.

There was a brief discussion on arrangements for next year's event.

24/68.5 Water Polo: No committee

IM reported that there is good activity in the county for the water polo discipline. Players from Watford WPC compete well in the inter-regional team competitions. Successful Junior and Senior competitions have been held by Hitchin SC during the summer. Hertford SC have set up a junior section for water polo.
